




### What is a national biodiversity platform?



A national biodiversity platform is a framework for bringing together stakeholders in collaborative relationships to consider the full value of Biodiversity and Ecosystem Services, and their contributions to society and well-being, in decision-making.







Supporting an overarching goal: improved inclusion of biodiversity considerations in decision-making to support transformative changes towards sustainable development

#### Researchers

Support science communication within policy processes

Stimulate interactions between natural & social sciences disciplines

#### Policymakers

Access researchers & evidence-base for policy design

Communicate policy questions to science community

Interact with stakeholders directly affected by policies

Support in science-policy processes

#### Practitioners

Access best-available knowledge to apply in their work

Channel their knowledge into policy processes

#### Private sector

Assess biodiversity benefits, dependencies & risks in supply chains

Understand policy developments affecting sector & share best practices to inform policy design

Co-produce knowledge

#### Civil society organisations

Understand policy developments & provide inputs into policy processes

Access data for technical & advocacy work

Co-produce knowledge & collaborate on initiatives

#### Indigenous peoples and local communities

Access to policy processes to share insights on biodiversity (e.g., resource management models) & social processes (e.g., cultural impacts of policies)

Co-produce knowledge with science community



Using a foundational approach of transparent, accountable, inclusive and meaningful engagement of stakeholder groups in decision-making processes

### How national biodiversity platforms fit within the national ecosystem assessment process

- 1. A national biodiversity platform is one of the long-lasting components of the assessment process. This can be established anew by the assessment process, or can build upon an existing platform as needed.
- 2. Such platform encourages engagement between practitioners, policymakers, diverse knowledge holders and stakeholders. It supports the assessment process and provides ongoing communities of practice at the intersection of science and policy, which can assist decision-making processes.

# ESTABLISHING A NATIONAL BIODIVERSITY PLATFORM

Revival of the National Biodiversity Steering Committee

Malawi has an established national structure dealing with biodiversity as provided by the legal and institutional framework – The National biodiversity Steering Committee (NBSC).

- □NBSC provides guidance to sectors involved in biodiversity management. At the local level, the District Environmental Sub-Committees coordinate biodiversity issues in the district and Village Natural Resource Management Committees coordinate biodiversity activities at the community level
- NBSC establishment facilitated by EAD as Focal point for CBD
- The Committee is composed of key stakeholders in the sectors related to biodiversity management in Malawi.
  - Government departments
  - Academia
  - Private Sector
  - NGOs

# Reviving the NBSC

The NBSC has been dormant for some time due to its activities being dependent on emerging projects

The NEA team resolved in its meetings to revive this committee and serve as the National platform form for the NEA process.

A meeting with the NBSC members was organized to brief them about the NEA project and the need for their commitment to take up the mandates of a national platform as it were.

Other participants of this meeting included government officials, academia, NEA co-chairs, Research fellows, and a representative of NEA Authors

# Purpose of NBSC

To provide a forum for effective policy dialogue on frameworks, priority setting, and means of facilitating investment and transfer of technology on biodiversity initiatives in the country.

It will also enhance collaborative project development and implementation, with a view to optimize the contribution of biodiversity management programmes to sustainable development

## Role of the NBSC in the NEA Process

- As a national planning platform, the NBSC will be:
  - Reviewing and approving all key outputs of the national ecosystem assessment process,
    - Scoping report, and communication strategy
    - Assessment report
    - Policy briefs
    - All knowledge products emanating from the

assessment process.

- Technical advice including input in the process as the committee is a rich pool of experts from different sectors.
- To play an active role in the role of the trialogues.

# NATIONAL BIODIVERSITY PLATFORM HOW WAS IT ESTABLISHED / SELECTED?

- •To have a crucial role in actively connecting the resident expert communities on biodiversity and ecosystems services, <u>Ministry of Ecology and Natural Resources</u>, which is main coordinating authority on environment, and in particular, on biodiversity and ecosystems services, launched the establishment of National Biodiversity Platform.
- <u>Azerbaijan Branch Office of REC Caucasus</u> is main coordinating and implementing unit for National Biodiversity Platform and will appoint the secretary on partly paid basis for National Biodiversity Platform

# NATIONAL BIODIVERSITY PLATFORM STRUCTURE

#### **Coordination Board**

Chair

2 Vice chairs (each from Academia or NGO and government)



#### **Advisory Board**

Civil society institutions, academia and interested governmental authorities ( at least 18 persons)



#### Secretariat

Rec Caucasus Azerbaijan branch

# NATIONAL BIODIVERSITY PLATFORM HOW WAS IT ESTABLISHED / SELECTED?

Coordination Board establishes permanent and temporary working bodies (expert groups, working groups, commissions)

Coordination Board consisting of the Chairman of NBP and two vise-chairs. Chairman and two vise-chairs are selected from the representatives of Advisory Board.

# NATIONAL BIODIVERSITY PLATFORM HOW WAS IT ESTABLISHED / SELECTED?

Advisory Board is consisted of representatives of civil society institutions, academia and interested governmental authorities. Minimum requirement to the number of members – the number should be at least 18 persons

Advisory Board is open for scientists, civil society and policy makers, they could join to Advisory Board, just having official letter from the institutions which they are representing
